

**ORDINANCE NO. 02-19**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GOLETA, CALIFORNIA, ADOPTING WITHOUT CHANGE THE COUNTY OF SANTA BARBARA OLD TOWN REVITALIZATION PLAN AND TRANSFERRING TERRITORIAL JURISDICTION OVER THAT PROJECT AREA FROM THE REDEVELOPMENT AGENCY FOR THE COUNTY OF SANTA BARBARA TO THE REDEVELOPMENT AGENCY FOR THE CITY OF GOLETA

THE CITY COUNCIL OF THE CITY OF GOLETA DOES ORDAIN AS FOLLOWS:

SECTION 1. Recitals.

(a) The City of Goleta is newly incorporated.

(b) Prior to its incorporation, proponents for the City of Goleta and the Board of Supervisors for the County of Santa Barbara entered into a revenue neutrality agreement (the "Revenue Neutrality Agreement") as required by the provisions of California Government Code Section 56845, which Revenue Neutrality Agreement was enacted by a vote of the people on November 6, 2001, and ratified by the City Council for the City of Goleta on February 1, 2002 by Resolution No. 02-02.

(b) Prior to incorporation, the Redevelopment Agency for this area established pursuant to the Community Redevelopment Law ("CRL"), California Health and Safety Code, Section 33000 and following, was the Santa Barbara County Board of Supervisors.

(c) The County of Santa Barbara has previously established the Old Town Revitalization Plan Redevelopment Project Area (the "Project Area") which is located totally within the jurisdiction of the newly incorporated City of

Goleta.

(d) By Ordinance No. 02-08 the City Council for the City of Goleta declared the necessity of and established the Redevelopment Agency for the City of Goleta and further declared the City Council to be the Redevelopment Agency Board for the community; and

(d) The City Council now, pursuant to the provisions of Section 33215 of the California Health and Safety Code, is authorized to adopt without change the Old Town Revitalization Plan established by the County of Santa Barbara and to unilaterally transfer territorial jurisdiction over that Project Area from the County of Santa Barbara to the Redevelopment Agency for the City of Goleta upon terms and conditions set forth in the Revenue Neutrality Agreement so long as the City agrees to reimburse the County of Santa Barbara for all costs incurred in conducting that transfer of jurisdictional authority.

#### SECTION 2. Adoption of Plan.

The City Council of the City of Goleta hereby adopts without change the Old Town Revitalization Plan as previously adopted by the County of Santa Barbara.

#### SECTION 3. Transfer of Territorial Jurisdiction.

The City Council of the City of Goleta hereby unilaterally transfers territorial jurisdiction over the Project Area from the Redevelopment Agency for County of Santa Barbara to the Redevelopment Agency for the City of Goleta in accord with the provisions of California Government Code Section 33215 and the terms of the Revenue Neutrality Agreement.

#### SECTION 4. Transfer of Redevelopment Funds to City

Transfer of redevelopment funds to the City for the Project Area, as well as planning authority with regard to the Project Area has already occurred pursuant to the terms of the Revenue Neutrality Agreement.

SECTION 4. Reimbursement of Costs for Conducting Transfer of Jurisdiction.

The City Council of the City of Goleta hereby agrees to reimburse all costs, if any, that may be incurred by the County of Santa Barbara in conducting the transfer of territorial jurisdiction over the Project Area as set forth in California Government Code Section 33215.

SECTION 5. Effective Date.

This Ordinance shall take effect on the first day of the fiscal year beginning July 1, 2002.


SECTION 6. Certification and Posting.


