

ORDINANCE NO. 02-08

AN URGENCY ORDINANCE OF THE CITY
COUNCIL OF THE CITY OF GOLETA,
CALIFORNIA, DECLARING THE CITY COUNCIL
TO BE THE REDEVELOPMENT AGENCY FOR THE
CITY AND APPOINTING THE CITY COUNCIL
MEMBERS AS THE MEMBERS THEREOF

THE CITY COUNCIL OF THE CITY OF GOLETA DOES ORDAIN AS
FOLLOWS:

SECTION 1. Recitals.

- (a) The City of Goleta is newly incorporated.
- (b) Prior to incorporation, the Redevelopment Agency for this area established pursuant to the Community Redevelopment Law ("CRL"), California Health and Safety Code, Section 33000 and following, was the Santa Barbara County Board of Supervisors.
- (c) Section 33200 of the CRL authorizes the City Council to declare itself to be the Redevelopment Agency for the community.
- (d) Among the reasons for the incorporation of the City and the election of a City Council, was the desire of the citizens of the area to have greater control over local development, land use and planning matters.
- (e) In order to allow the Redevelopment Agency continue to operate, the City Council must also give direction to the County of Santa Barbara Auditor/Controller with regard to authorization to continue to fund such operations which will continue to be provided by County staff until further order of the City or the Redevelopment Agency.
- (f) Declaring the City Council to be the Redevelopment Agency of the community will serve the public interest and promote the public safety and

welfare in a more effective manner because it will allow the duly elected representatives of the City to control the redevelopment activities occurring within the community.

SECTION 2. The City Council of the City of Goleta is hereby declared to be the Redevelopment Agency for the City. The members of the City Council shall serve as the members of the Redevelopment Agency. They shall perform the functions and have all of the rights, powers, duties, privileges and immunities prescribed in the Community Redevelopment Law, and shall fulfill the functions previously performed by the members of the Santa Barbara County Board of Supervisors under the Santa Barbara County Code and relevant County ordinances and resolutions, which the City has adopted by reference.

SECTION 3. In order to allow for the Redevelopment Agency to continue to fund and operate in order to fulfill its functions, the City Council hereby directs the County Auditor/Controller to continue funding operations and staffing for the Redevelopment Agency as an Agency of the City of Goleta which services shall continue to be provided by the County of Santa Barbara staff until further action of the City or the Redevelopment Agency.

SECTION 4. In accordance with CRL Section 33114.5, in addition to payment for all of their actual and necessary expenses, including travel expenses incurred in the discharge of their duties, each member of the Redevelopment Agency shall be paid thirty dollars (\$30) for each meeting of the Agency attended by such member; provided, however, no member shall receive compensation for attending more than four meeting of the Agency during any calendar month.


SECTION 5. Unless this ordinance takes effect immediately upon its adoption, the functions of the Redevelopment Agency for the community will continue to be carried out by members of the Santa Barbara County Board or Supervisors rather than the duly elected officers of the City. Therefore, the City Council finds that this ordinance is necessary for the protection of the public health, safety, interest and general welfare, and declares that it shall take effect immediately upon its adoption.

SECTION 6. The City Clerk shall certify the adoption of this ordinance and shall cause the same to be posted as required by law.


